



REQUEST FOR QUOTATION FOR NEW PAINT BOOTHS AND
RELOCATING EXISTING PAINT BOOTHS

Background

Commercial Colours Ltd (CCL) are an established commercial vehicle body in the northwest and North Wales. We carry out crash repairs on all sizes and types of commercial vehicles plus painting of new and used commercial vehicles. Our client base consists of owner drivers and small operators right up to the major fleets that are seen on Britain's roads every day. Due to increased demand, we are looking to expand our operation into a larger site.

Requirement

We have the requirement for the following;

3 x new commercial vehicle spray booths, 5x5x16 in size, rear extract, gas fired and roller shutter access.

2 x new van spray booths, 3.5x4x10 in size, rear extract, gas fired and roller shutter access.

1 x new ventilated and lit paint mixing room, 3x5x5.

Disassemble, transport 6 miles, re-assemble and recommission 1 x 5x5x16 commercial spray booth.

Deliverable Timescale

We expect the project to commence no later than 1st March 2022, and to be completed by 31st May 2022

Evaluation Criteria

Quotations will be assessed and scored on the following criteria:

Cost 10%

Does supplier offer value for money. This will not necessarily be the cheapest quote

Deliverability Within Specified Timescales 20%

Supplier must demonstrate they can deliver the requirement to timescales above

Meeting Specification Details 40%

Supplier must demonstrate all specifications met

Supplier Suitability 30%

Supplier must demonstrate they have the technical capability and experience to deliver the requirement

Scoring Methodology

4 Excellent	Proposal meets, and in some places exceeds the required standard
3 Good	Proposal meets required standard
2 Acceptable	Proposal meets the required standard in most respects, but is lacking or inconsistent in others
1 Poor	Proposal falls short of expected standard
0 Unacceptable	Completely or significantly fails to meet required standard or does not provide the relevant answer

Proposals should clearly demonstrate how they meet the requirement set out above.
